With the entry into force of the EU Regulation 2016/679 on the protection of natural persons for the processing of personal data and their free circulation, as "Interested", we inform you about how your personal data are used by Our Company, so as to guarantee a correct and transparent treatment towards it in respect of the principles of application that are placed to protect your personal rights and freedoms.

WHO WE ARE:

YOUR DATA ARE USED FOR:

Your personal data are processed in relation to the contractual relationships with you held and the consequent fulfilment of legal, fiscal and administrative obligations, as well as to allow an effective management of the related financial and commercial relationships. Within our organization can be collected and catalogued also the data of direct delivery (telephone number, email, contact details, etc.) referred to its workers and collaborators and also specific company data always related to the contract in place between the parties, in order to improve the related business contact references. These treatments are considered necessary to supply the services correctly to the interested parties.

We also use its data to improve and implement our professional service, through communications aimed at informing data subjects to promote and publicize commercial offers, promotional initiatives, activities related to our products and corporate communications.

These activities can be managed by telephone, fax, e-mail, newsletter service, sms, both by operator and in computerized form, in the ways and within the limits necessary to pursue the aforementioned purpose.

YOUR DATA ARE COMMUNICATED TO:

The data are processed at the operational headquarters of the Data Controller and in any other place where the parties involved in the processing are located. Your data may be communicated to our managers and responsible for processing both internal and external previously accredited and authorized by us and will be processed by them exclusively for purposes intrinsic to the contractual relationship established between the parties, more precisely:

to internal subjects in charge of our company: Administrative Area, Technical Area, Production Area;

external subjects who need access to your data for purposes auxiliary to the relationship between the parties, within the limits strictly necessary to perform the tasks assigned to them: Business studies, consulting studies for accounting-tax-contributory accounting management, Credit institutes, social security and welfare institutions, financial offices, tax authorities;

to external subjects, our consultants, within the limits necessary to carry out their duties at our company: Security Manager, IT Manager, Responsible for the management of electronic mail and the website.

Your data may also be disclosed to third parties, if the need arises, for the sole purpose of following up or completing the service or provision requested (shipping service, ...) The complete and updated list of persons in charge and managers can always be requested from the Data Controller in the manner indicated in this statement. All data processors and processors authorized to access personal data have been identified individually within our management system, and have received appropriate instructions on the correct treatment modalities to guarantee the rights of data subjects through the application of measures techniques and organization aimed at preserving a level of security appropriate to the risk, in addition to the requirement of the obligation to respect the right of confidentiality of the data subjects. We also specify that your data will not be object of our disclosure to unauthorized third parties for purposes other than those listed in this statement. We inform you that the processing of data will be carried out exclusively in Italy, without any kind of transfer to third countries outside the European Union.

YOUR DATA WILL BE KEPT IN THE FOLLOWING METHODS:

Our company will keep its data in its archives for the period corresponding to the fiscal, accounting and administrative requirements in relation to the relative reference regulations. They will also be retained even after the eventual termination of the contractual or pre-contractual relationship stipulated for a maximum of 10 years in order to document their regular activity and also to respond to any need for data recovery. At the end of the period provided, the data will be destroyed or otherwise

processed ensuring compliance with the principle of minimization to protect the rights and freedoms of the data subject and always keeping them with adequate security measures.

YOUR DATA WILL BE TREATED IN THE FOLLOWING METHODS:

The data acquired will be processed by us with paper, computer or electronic support, within and for the purposes indicated in the information. The processing of data is done through the use of tools and procedures deemed appropriate to ensure security, confidentiality and saving on automatic backups. These measures have been reported in our Privacy management system (Angel), which allows a constant monitoring of protection against the data processed and a continuous adjustment of the procedures based on the evolution of the company. We also point out that we do NOT use automated decision-making within our organization, including profiling, that produces legal effects that affect you and that significantly affect you.

YOUR OBLIGATIONS WILL BE:

We remind you that the communication of personal data is mandatory and is set as a necessary requirement for the conclusion of the contract or to fulfil pre-contractual agreements. You have the right to provide us with the requested data, however in the absence of the same, we will not be able to respond to your request, or provide an adequate service, or within the required time, or could result in failure or partial execution of the task entrusted.

YOUR RIGHTS WILL BE:

At any time you can assert, in our comparisons, your rights of Interested under the EU Regulation 2016/679 within the limits and under the conditions provided for by art. 12 of the same Regulation: art.15) Right of access, art. 16) Right of rectification, art. 17) Right to cancel, art. 18) Limitation rights, art. 20) Right to data portability, art. 21) Right of opposition, art. 22) Right to revoke the consent given. Furthermore, its right to lodge a complaint with the supervisory authority is retained if it deems that our treatment modalities are not in conformity.
